**REGULAR SESSION:**

**Item 1.** Gene Giger made a motion to approve Variance request (V-12-04) at 901 Stonebrook Drive as recommended by the Planning & Zoning Commission. Janeice Lunsford seconded the motion. Motion Carried unanimously.
