**DECLARING A LOCAL STATE OF DISASTER  
CITY OF CHANDLER, TX**

**WHEREAS**, the City of Chandler on the 29<sup>th</sup> (previous AND following days) day of May, 2015 has suffered widespread or severe damage, injury, or loss of life or property (or there is imminent threat of same) resulting from flooding, heavy rainfall, and other severe weather,

**WHEREAS**, the City Council of the City of Chandler, TX has determined that extraordinary measures must be taken to alleviate the suffering of people and to protect or rehabilitate property;

**NOW, THEREFORE, BE IT PROCLAIMED BY THE CITY COUNCIL OF THE CITY OF CHANDLER, TX:**

1. That a state of disaster is declared for the CITY OF CHANDLER, TX to include all dates contained in the State of Texas Disaster Declaration.
2. That the City's Emergency Management Plan has been implemented.
3. That this state of disaster shall continue for a period of not more than twenty-eight days of the date hereof, unless the same is continued by consent of the City Council of the City of Chandler, TX.
4. That this proclamation shall take effect immediately from and after its issuance
