- G. REGULAR SESSION: Subjects to be discussed or upon which any formal action may be taken are as follows:
  - 1. Consider and act on Planning & Zonings recommendation to grant a variance from the required ROW for Parker Street from the 60' to 40' and no ROW change for W. Main Street from 60' on property described as AB 136 SCALDERON SUR, TR 171(Part of 1.05 AC) and AB 799 S WEISS SUR, TR 271(Part of 1.05 AC). This property is located between the Family Dollar Store and the Texas Pecan Nursery on St. Hwy. 31.
  - 2. Consider and act Planning & Zonings recommendation to approve the Final Plat of AB 136 SCALDERON SUR, TR 171(Part of 1.05 AC) and AB 799 S WEISS SUR, TR 271(Part of 1.05 AC) contingent upon ROW changes being made prior to the Council meeting.
  - 3. Consider and act on entering into a contract with CopSync to provide the city with software and hardware required to place the Chandler Police Department in the CopSync Program.
  - 4. Consider and act on a Resolution regarding a finance contract for the purpose of procuring CopSync Equipment and designating Jim Moffeit, City Administrator as an authorized signer of the finance contract.
  - 5. Consider and act on pump truck dumping at the cities Waste Water Treatment Plant.
  - 6. Consider and act on renewing contract with Henderson County Tax Office to perform all duties provided by the State of Texas for collection of taxes for the City of Chandler.
  - 7. Consider and act on appointing a board member to fill George Grantham's

position on the Planning and Zoning Commission for a two year term.

8. Consider and act on an Ordinance designating speed limits on all city streets at 20 miles per hour unless otherwise posted.

9. Consider and act on an Ordinance to install a 3-way stop sign at M.A. Wallace and Third St.

10. Consider and act on an Ordinance to establish a no parking zone on FM 315 (Broad St.) in the area of the Chandler Elementary School.
