\_\_\_\_\_ I hereby enter my appearance, and waive my right to a jury trial, and enter a plea of No Contest;

\_\_\_\_\_ I was not charged with speeding in excess of 24 mph over the posted speed limit and I have confirmed my offense is eligible with Chandler Municipal Court: (903)849-6853;

\_\_\_\_\_ I am submitting a photocopy of my valid Texas Driver's License AND proof of financial responsibility in my name, that is valid on the date of this request;

\_\_\_\_\_ I am aware that court cost and dismissal fee for a **Speeding** ticket is **\$109.10** or court cost and dismissal fee for a **Speeding in School Zone** ticket is **\$134.10**. I am enclosing the correct amount along with my application;

\_\_\_\_\_ I am not currently in the process nor have I completed a DSC within the 12 months preceding the date of my citation;

\_\_\_\_\_ I agree to complete a DSC and present to the court, NO LATER THAN 90 DAYS from the date that my request is approved, a certified copy of my driving record from the DPS(www.texas.gov), AND the "COURT" copy of the DSC certificate;

\_\_\_\_\_ I understand that my failure to fully comply with these requirements may result in a conviction to my driving record as required by law, and possibly incur additional fees.
